3) The Sorrento Football Club Inc. (SFC) was formed on the 9th of February 1972.

4) MISSION

8) GENERAL INFORMATION FOR PLAYERS AT TRIALS

- a) Players are expected to attend all scheduled sessions for their age group.
- b) Players must wear authentic football boots that are a good fit and not be split or missing studs. Boot laces must be in good condition and of good strength. Shin pads must be worn and are not to be split and must be of appropriate size. No jewellery to be worn.
- **c**) Any injury, especially if bleeding, is to be immediately brought to the attention of the coaching staff.
- d) Only players and coaching staff are to be inside the pitch perimeter fencing.
- e) Only players and coaching staff are to be inside the change rooms at any time.
- **f**) Any rubbish (left over drink container) is to be placed in the bins provided in every change rooms and near the pitch.

9) **SELECTION**

- a) The Panel that undertakes the evaluation of players consists of at least 4 persons; Normally, our Technical Director, Coaching Co-ordinator, Coach of the top tier team & Coach of 2nd tier team.
- b) Once a player has been selected for a team, then an e-mail with registration and payment details will be sent to the player/parent. Every player will be informed as to which level/tier they have been assessed or of their non-selection.
- c) Your acceptance of the position offered is only when the completed form and payment has been completed. This must be done within seven (7) days of you being handed the form. If your acceptance (form and payment) is not received within 7 days (Note: Not business days), it is presumed that you no longer required the position and it will be offered to another player.





10) CLUB

- a) Sorrento FC strives to attract, develop and retain the best coaches. We feel we are a very structured club and one club. That is, there is only one Committee and thus the juniors, seniors, masters, social players and our non-playing members are "under one umbrella". There is a clear progression path for players, whether they are of 1st tier standard or of our 2nd tier or 3rd tier.
- b) Everyone is encouraged to utilize the Club's facilities. Almost all this Club's facilities, except the actual grounds, have been built or purchased by this Club. Sorrento FC is totally responsible for the maintenance and any extensions/improvements of its own club house. Generally, clubs use Shire/Council facilities at no or little cost/charge. We do not have that situation. Our club is ours whilst we occupy it. The advantage is that we do not have to share club house and thus can use the club 12 months of the year, but that comes at a cost. We have to pay all insurances, electricity; water rates; City of Joondalup rates, club house cleaning and cleaning equipment/consumables; maintenance of canteen, change rooms & club house; hand towels, toilet consumables; licenses; rubbish collection; painting, telephone rent; broadband, stationary; etc. The City of Joondalup is responsible for the maintenance of the pitches. Although we do extra top dressing, mowing, weeding and fertilizing ourselves.
